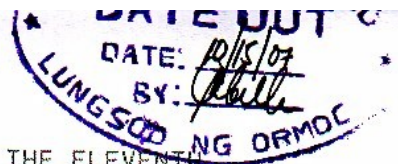

RESOLUTION NO. 2007-089

A RESOLUTION VEHEMENTLY OBJECTING TO THE PROPOSED
INCREASE OF SERVICE CHARGES OF PHILIPPINE PORTS
AUTHORITY (PPA) BASED ON PPA ADMINISTRATIVE ORDER NO.
08-98 AND E.O. 197 PROVIDING PPA TO INCREASE SERVICE
CHARGES BY NOT LESS THAN 20%.

WHEREAS, PPA Administrative Order No. 08-96 and E.O. 197 as
Implemented by DOF-DBM Joint Circular No. 2-04 has directed all
government agencies, including government owned and controlled
corporations to increase their rates of fees and charges by not less
than 20%;

WHEREAS, such kind of increase is unconscionable because it does
not set a ceiling but rather a floor rate limitation;

WHEREAS, such increase will put the commuting public at the mercy
of government agencies, including government owned and controlled
corporations because they can just make increases subject to their whims
since the public may not be anymore consulted;

WHEREAS, in order to protect the interest of the riding public in
general and the commuters of Ormoc in particular, this Sanggunian
believes that passage of this resolution is proper;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on MASS MOTION of the
Body; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution VEHEMENTLY
OBJECTING TO THE PROPOSED INCREASE OF SERVICE CHARGES OF PHILIPPINE
PORTS AUTHORITY (PPA) BASED ON PPA ADMINISTRATIVE ORDER NO. 08-98 AND
E.O. 197 PROVIDING PPA TO INCREASE SERVICE CHARGES BY NOT LESS THAN 20%;


