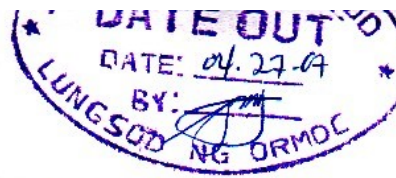

ADOPTED, April 26, 2007.


