RESOLUTION NO. 2007-096

A RESOLUTION APPROVING ORDINANCE 2007-002 OF THE BARANGAY
COUNCIL OF BARANGAY IPIL, THIS CITY, ENTITLED: "AN
ORDINANCE IMPOSING A TAX ON STORES OR RETAILERS WITH A
FIXED BUSINESS ESTABLISHMENT, OPERATING WITHIN THIS
BARANGAY, CHARGES ON OUTDOOR SIGNS, SIGNBOARDS, AND
BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS
ISSUED BY THE BARANGAY TO ANY PERSON".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2007-002 of the Barangay Council of Barangay Ipil, entitled: "AN
ORDINANCE IMPOSING A TAX ON STORES, OR RETAILERS WITH A FIXED BUSINESS
ESTABLISHMENT, OPERATING WITHIN THIS BARANGAY, CHARGES ON OUTDOOR SIGNS,
SIGNBOARDS, AND BILLBOARDS, AND FEES ON CLEARANCES AND CERTIFICATIONS
ISSUED BY THE BARANGAY TO ANY PERSON";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relations to the
aforecited ordinance at issue (and all ordinances of the Sangguniang
Barangay in Ormoc City is, by law, granted the Power to review as to
whether said ordinance is consistent with law and city x x x ordinances;

WHEREAS, it can be recalled that the said Ordinance was submitted
to this august Body for review and was found to have some deficiencies,
hence, the same was returned to the barangay of origin for correction;

WHEREAS, lately, however, the same was submitted anew to this
Sanggunian as corrected;

WHEREAS, it is the observation of the august Body that the said
ordinance has conformed to the pertinent provisions of the Local
Government Code, hence, reasonable and within the province of the
Sangguniang Barangay of Ipil to legislate;
