A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF AGRICULTURE- REGIONAL FIELD UNIT NO. 8 (DA-RFU 8) FOR THE PROVISION OF THE AMOUNT OF ONE MILLION EIGHTY ONE THOUSAND SIX HUNDRED FIFTY ONE PESOS & 59/100 (P1,081,651.59) FOR THE IMPLEMENTATION OF AGRICULTURAL REHABILITATION ACTIVITIES AND PROJECTS.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc is in receipt of an indorsement dated October 15, 2007 from the Honorable City Mayor Eric C. Codilla urgently requesting for the passage of a resolution authorizing His Honor to enter into and sign a Memorandum of Agreement in behalf of the City Government of Ormoc with the Department of Agriculture- Region 8 for the provision of the amount of One Million Eighty One Thousand Six Hundred Fifty One Pesos & 59/100 (P1,081,651.59) for the procurement of seeds/ planting materials and other production support components/ inputs for the implementation of agricultural rehabilitation activities and projects;

WHEREAS, said Memorandum of Agreement mentions that the said funds has been received by the Department of Agriculture- Regional Field Unit No. 8 (DA-RFU 8) from its Central Office under the Calamity Assistance Rehabilitation Enhancement (CARE) Plan for the implementation of various activities and projects to restore agricultural activities in areas affected by various calamities;

WHEREAS, the City of Ormoc, has been identified as one of those areas which sustained a significant agricultural production shortfall, thus requires support intervention from the Department of Agriculture;

WHEREAS, this August Body believes that said Memorandum of Agreement is beneficial and would be of great help in boosting the city's agricultural sector, hence, the requested authority by the Honorable City Mayor to sign the same be accorded due course of action;
