A RESOLUTION APPROVING ORDINANCE NO. 2007-02 OF THE  
BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY,  
ENTITLED: AN ORDINANCE IMPOSING GARBAGE FEE COLLECTION  
IN THE AMOUNT OF ONE PESO (p 1.00) PER DAY OR THIRTY  
PESOS (P 30.00) PER MONTH COLLECTED FROM EVERY  
HOUSEHOLD AND ONE PESO (P 1.00) PER BAG (50 KILOGRAMS  
RICE BAG) FROM ALL BUSINESS ESTABLISHMENTS OPERATING  
WITHIN THE JURISDICTION OF BARANGAY COGON, ORMOC CITY

WHEREAS, this sangguniang is in receipt of Barangay Ordinance No. 2007-02 of the Barangay Council of Barangay Cogon, entitled: "AN ORDINANCE IMPOSING GARBAGE FEE COLLECTION IN THE AMOUNT OF ONE PESO (P 1.00) PER DAY OR THIRTY PESOS (P 30.00) PER MONTH COLLECTED FROM EVERY HOUSEHOLD AND ONE PESO (P 1.00) PER BAG (50 KILOGRAMS RICE BAG) FROM ALL ESTABLISHMENTS OPERATING WITHIN THE JURISDICTION OF BARANGAY COGON, ORMOC CITY";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforceited ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinances; (sec 57, 1991 LGC);

WHEREAS, it is the observation of this august Body that said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Cogon to legislate;

WHEREFORE, foregoing premises considered, on motion of this City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Fe S. Lladoc, Sotero M. Pepito and Claudio P. Larrazabal; be it.
