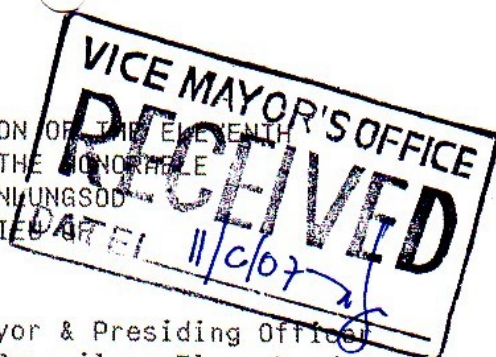

RESOLUTION NO. 2007-0100

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE GERMAN DEVELOPMENT SERVICE (DED) FOR A PROJECT GRANT IN THE AMOUNT OF SEVENTY NINE THOUSAND PESOS (P79,000.00) FOR THE PURCHASE OF ONE (1) UNIT LCD PROJECTOR FOR THE CITY'S SOLID WASTE MANAGEMENT PROGRAM.

WHEREAS, this august Body is in receipt of an indorsement dated October 30, 2007 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing His Honor to enter into and sign a Memorandum of Agreement in behalf of the City Government of Ormoc with the German Development Service (DED) for a project grant in the amount of Seventy Nine Thousand Pesos (P79,000.00) for the purchase of 1 unit LCD Projector for the Solid Waste Management Program of the city;

WHEREAS, said Memorandum of Agreement mentions that the total cost of the project is P118,900.00 and the city will have to put up a counterpart for said project in the amount of more or less P39,900.00 which represents the cost of the Lap-Top;

WHEREAS, the DED shall transfer the amount of P79,000.00 to the City Government of Ormoc being the Project Holder and the same shall be used solely for the purpose herein after mentioned;

WHEREAS, this Sanggunian believes that the project grant is important in the effective implementation and monitoring of activities initiated by the solid waste management coordinators of the city, hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Jose C. Alfaro, Jr., Chairman, Committee on Environment, jointly seconded by City Councilors Rafael C. Omega, Jr. and Ruben R. Capahi; be it
