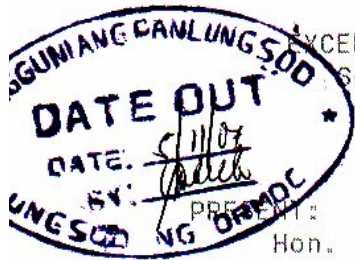

A RESOLUTION APPROVING ORDINANCE NO. 2007-03 OF THE  
BARANGAY COUNCIL OF BARANGAY COGON, THIS CITY,  
ENTITLED: AN ORDINANCE AMENDING SOME PROVISIONS OF  
BARANGAY ORDINANCE NO. 1992-01, ENTITLED "AN ORDINANCE  
PRESCRIBING (SIC) THE RATES ON THE ISSUANCE OF BARANGAY  
CLEARANCES, CERTIFICATES, PERMITS AND OTHER CHARGES"

WHEREAS, this sangguniang is in receipt of Barangay Ordinance No. 2007-03 of the Barangay Council of barangay Cogon, entitled: AN ORDINANCE NO. 1992-01, ENTITLED "AN ORDINANCE PRESCRIBING (SIC) THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES, THIS CERTIFICATES, PERMITS AND OTHER CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforesaid ordinance at issue (and all other ordinances of the Sangguniang Barangay in Ormoc City) is, by law, granted the power to review as to whether said ordinance is consistent with law and city ordinance; (Sec. 57, 1991 LGC);

WHEREAS, it is the observation of this august Body that the said ordinance has conformed to the pertinent provisions of the Local Government Code, hence, reasonable and within the province of the Sangguniang Barangay of Cogon to legislate;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Sotero M. Pepito; be it
