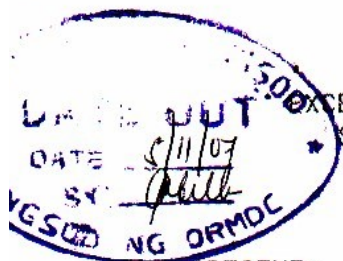

RESOLUTION NO. 2007-102

A RESOLUTION APPROVING ORDINANCE NO. 2007-01 OF THE  
BARANGAY COUNCIL OF BARANGAY JUATON, THIS CITY,  
ENTITLED: "AN ORDINANCE CREATING THE BARANGAY COUNCIL  
FOR THE PREVENTION OF TRAFFICKING IN PERSONS AND  
PROTECTION FOR THE VICTIMS/SURVIVORS OF TRAFFICKING".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.  
2007-001 of the Barangay Council of Barangay Juaton, entitled: "AN  
ORDINANCE CREATING THE BARANGAY COUNCIL FOR THE PREVENTION OF  
TRAFFICKING IN PERSONS AND PROTECTION FOR THE VICTIMS/SURVIVORS OF  
TRAFFICKING";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to  
review as to whether said ordinance is consistent with law and city x x  
ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of the august Body that the said  
ordinance has conformed to the pertinent provisions of the Local  
Government Code, hence, reasonable and within the province of the  
Sangguniang Barangay of Juaton to legislate;

Laws and Ordinances and Committee on Social Welfare and Development,


