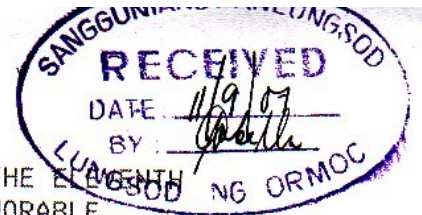

INCORPORATED.


