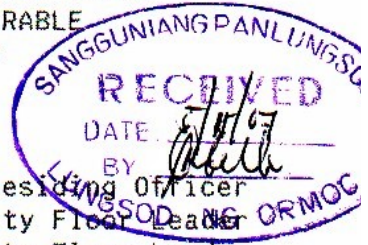
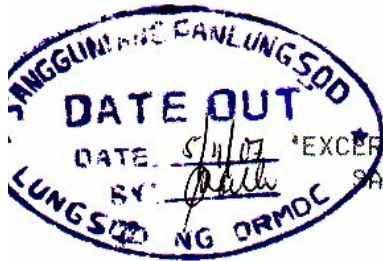

A RESOLUTION APPROVING ORDINANCE NO. 2007-003 OF THE  
BARANGAY COUNCIL OF BARANGAY DON CARLOS RIVILLA, SR.,  
THIS CITY, ENTITLED: "AN ORDINANCE PROHIBITING  
RESIDENTS OF THIS BARANGAY FROM THE INDISCRIMINATE  
THROWING OF GARBAGE AND/OR UNSANITARY DISPOSAL OF ANY  
WASTE MATERIALS, PROVIDING PENALTIES THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.  
2007-003 of the Barangay Council of Barangay Don Carlos Rivilla Sr.,  
entitled: "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM THE  
INDISCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF ANY  
WASTE MATERIALS PROVIDING PENALTIES THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to  
review as to whether said ordinance is consistent with law and city x x  
ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of the august Body that the said  
ordinance has conformed to the pertinent provisions of the Local  
Government Code, hence, reasonable and within the province of the  
Sangguniang Barangay of Don Carlos Rivilla, Sr., to legislate;
