

## RESOLUTION NO. 2007-103

APPROVING ORDINANCE NO. 2007-003 OF THE A RESOLUTION BARANGAY COUNCIL OF BARANGAY DON CARLOS RIVILLA, SR., ENTITLED: "AN ORDINANCE PROHIBITING THIS BARANGAY FROM THE INDISCRIMINATE CITY, THIS CALL, RESIDENTS OF THIS BARANGAY FROM THE INDIDENTIFICATION OF GARBAGE AND/OR UNSANITARY DISPOSAL OF ANY THE DENALTIES THEREOF".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2007-003 of the Barangay Council of Barangay Don Carlos Rivilla entitled: "AN ORDINANCE PROHIBITING RESIDENTS OF THIS BARANGAY FROM INDISCRIMINATE THROWING OF GARBAGE, AND/OR UNSANITARY DISPOSAL OF WASTE MATERIAL'S PROVIDING PENALTIES THEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to aforecited ordinance at issue (and all other ordinances of Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city x x x ordinances; (Sec. 57, 1991 LGC)
