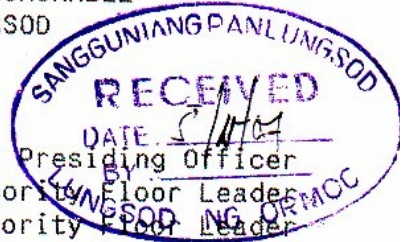

A RESOLUTION APPROVING THE UNNUMBERED ORDINANCE OF THE
BARANGAY COUNCIL OF BARANGAY DON CARLOS RIVILLA, SR.,
THIS CITY, ENTITLED: "AN ORDINANCE CREATING THE
BARANGAY COUNCIL FOR THE PREVENTION OF TRAFFICKING IN
PERSONS AND PROTECTING FOR THE VICTIMS/SURVIVORS OF
TRAFFICKING".

WHEREAS, the Tenth Sangguniang Panlungsod ng Ormoc is in receipt of
an unnumbered Barangay Ordinance of the Barangay Council of Barangay Don
Carlos Rivilla, Sr. entitled: "AN ORDINANCE CREATING THE BARANGAY
COUNCIL FOR THE PREVENTION OF TRAFFICKING IN PERSONS AND PROTECTING FOR
THE VICTIMS/SURVIVORS OF TRAFFICKING";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the
aforecited ordinance at issue (and all other ordinances of the
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to
review as to whether said ordinance is consistent with law and city x x
ordinances (Sec. 57, 1991 LGC);
