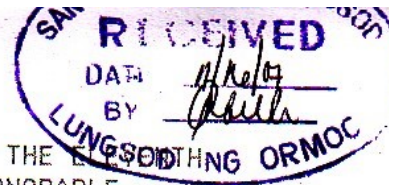

RESOLUTION NO. 2007-106

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE AMENDED MEMORANDUM OF AGREEMENT (MOA) BETWEEN THE CITY GOVERNMENT OF ORMOC, BARANGAY NAUNGAN, THIS CITY, THE NAUNGAN - SAN JUAN MANGROVE PLANTERS ASSOCIATION, THE DEPARTMENT OF ENVIRONMENT AND NATURAL RESOURCES AND THE DEUTSCHE GESSELLSCHAFT FUR TECHNISCHE ZUSAMMENARBEIT (GTZ) FOR THE FINANCING AND IMPLEMENTATION AGREEMENT IN SUPPORT TO THE COMMUNITY BASED FORESTRY MANAGEMENT ACTIVITIES.

WHEREAS, this august Body is in receipt of an indorsement dated November 06, 2007 from the Office of the City Mayor urgently requesting for the passage of a resolution authorizing the Honorable City Mayor to sign the amended Memorandum of Agreement between the City Government of Ormoc, Barangay Naungan, the Naungan - San Juan Mangrove Planters Association, the Department of Environment and Natural Resources (DENR), and the Deutsche Gessellschaft Fur Technische Zusammenarbeit;

WHEREAS, said Memorandum of Agreement refers to the financing and implementation agreement by the above parties in support to the Community Based Forestry Management (CBFM) Activities in the City of Ormoc to be undertaken by the People's Organization (PO) known as the Naungan - San Juan Mangrove Planters Association (NSJMPA);

WHEREAS, it can be recalled that this sanggunian has earlier approved SP Resolution No. 2007-016 dated July 12, 2007 which authorizes the Honorable City Mayor to sign the previous Memorandum of Agreement between the DENR, LGU - Ormoc and GTZ for the development and strengthening of the organized People's Organization (PO) registered in the name of Naungan and San Juan Mangrove Planters Association (NSJMPA);

WHEREAS, the purpose of this Memorandum of Agreement is to formalize in a binding instrument the roles and responsibilities of the parties involved in implementing the CBFM - related activities in form of 5 hectares Mangrove Reforestation in areas herein mentioned;



WHEREAS, this august Body believes that the provisions of the Memorandum of Agreement are just and reasonable hence, be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor, Jose C. Alfaro, Jr., Chairman, Committee on Natural Resources, jointly seconded by City Councilor Sotero M. Pepito and Mariano Y. Corro ; be it
