RESOLUTION NO. 2007-110

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF  
SABANG BAO, THIS CITY, THEIR TAX ORDINANCE NO. 01,  
SERIES OF 2007, ENTITLED: "AN ORDINANCE IMPOSING A TAX  
ON STORE OR RETAILERS WITH A FIXED BUSINESS  
ESTABLISHMENT OPERATING WITHIN THIS BARANGAY AND OTHER  
FEES AND CHARGES" FOR THE REASON STATED HEREIN.

WHEREAS, this Sanggunian is in receipt of Tax Ordinance No. 01,  
Series of 2007 of the Barangay Council of Barangay Sabang Bao, entitled:  
"AN ORDINANCE IMPOSING A TAX ON STORE OR RETAILERS WITH A FIXED BUSINESS  
ESTABLISHMENT OPERATING WITHIN THIS BARANGAY AND OTHER FEES AND  
CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the  
aforecited ordinance at issue (and all other ordinances of the  
Sangguniang Barangay in Ormoc City) is, by law, granted the Power to  
review as to whether said ordinance is consistent with law and city x x

which sets the filing fee of not more than Twenty Pesos (P20.00) hence,  
same be returned for proper correction;

jointly seconded by City Councilors Jose C. Alfaro, Jr. and Manuel T.  
Fiel; be it




