RESOLUTION NO. 2007-110

A RESOLUTION TEMPORARILY UTILIZING A PORTION OF THE 2ND FLOOR OF BUILDING "B" OF THE NEW PUBLIC MARKET AS VEGETABLE TRADING CENTER/ VEGETABLE BAGSAKAN AREA, WHILE AWAITING COMPLETION OF THE PERMANENT VEGETABLE BAGSAKAN IN BARANGAY ALEGRIA, THIS CITY.

WHEREAS, Vegetable Trading Center/ Vegetable Bagsakan Area give incentives to the barangay residents to produce more vegetables, fruits and raise more livestock to enable them more profit, thus giving them additional income;

WHEREAS, it has been observed that the holding of Vegetable Trading Center/ Vegetable Bagsakan Area has provided more opportunity to vendors from different barangays to sell better kinds of vegetables and local producers are no longer victimized by unscrupulous middlemen or jobbers for they can now dispose what they bring directly to the consumers;

WHEREAS, in order to prevent spoilage of vegetables and to ease the burden of the vegetable farmers, the City Government of Ormoc has opted to temporarily designate a portion of the 2nd floor of the Building "B" of the New Public Market as Vegetable Trading Center/ Vegetable Bagsakan Area, while awaiting completion of the permanent Vegetable Bagsakan in Brgy. Alegria, this City;

WHEREAS, this august Body believes that said request is very reasonable, hence, the same must be accorded due course of action;

WHEREFORE, foregoing premise considered on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Agriculture, jointly seconded by city Councilor Mariano Y. Corro and Ruben R. Capahi; be it
