

RESOLUTION NO. 2007-112

A RESOLUTION RETURNING TO THE SANGGUNIANG BARANGAY OF DON CARLOS B. RIVILLA, SR., THIS CITY, THEIR BARANGAY ORDINANCE NO. 2007-004, ENTITLED: "AN ORDINANCE REGULATING THE BACKYARD HOG RAISING OPERATION OF THE RESIDENTS OF THIS BARANGAY, TO MAINTAIN THE HEALTH AND SANITATION OF THE PLACE, AND TO PRESERVE AND PROTECT THE ENVIRONMENT, PROVIDING PENALTIES FOR THE VIOLATION HEREOF" FOR THE REASON CITED HEREUNDER.

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No. 2007-004 of the Barangay Council of Barangay Don Carlos B. Rivilla Sr., entitled: "AN ORDINANCE REGULATING THE BACKYARD HOG RAISING OPERATION OF THE RESIDENTS OF THIS BARANGAY, TO MAINTAIN THE HEALTH AND SANITATION OF THE PLACE AND TO PRESERVE AND PROTECT THE ENVIRONMENT, PROVIDING PENALTIES FOR THE VIOLATION HEREOF";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the aforecited ordinance at issue (and all other ordinance of the Sangguniang Barangay in Ormoc City) is, by law, granted the Power to review as to whether said ordinance is consistent with law and city ordinances; (Sec. 57, 1991 LGC)

WHEREAS, it is the observation of this august Body that Sections 5 and 6 of said ordinance are ambiguous, hence, the same must be properly corrected;

WHEREFORE, foregoing premises considered, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Laws and Ordinances, severally seconded by City Councilors Claudio P. Larrazabal, Sotero M. Pepito and Ruben R. Capahi; be it
