A RESOLUTION SUPPORTING AND ENDORSING TO THE COMMUNITY ENVIRONMENT AND NATURAL RESOURCES OFFICE (CENRO) THE RESOLUTION NO. 8 SERIES OF 2007 OF THE BARANGAY COUNCIL OF BARANGAY LAO, THIS CITY, ENTITLED: "A RESOLUTION EARNESTLY REQUESTING MR. ALEJANDRO K. BAUTISTA, HEAD, CENRO, DENR, ALBUERA, LEYTE TO CONDUCT THE DELINEATION SURVEY OF ALL ILLEGALLY DEVELOPED FISHPONDS AND PRACTICALLY ALL PUBLIC LAND UNDER THE TERRITORIAL JURISDICTION OF BARANGAY LAO THIS CITY".

WHEREAS, the 10th Sangguniang Panlungsod ng Ormoc is in receipt of Resolution No. 8, Series of 2007 of the Barangay Council of Barangay Lao, entitled: "A RESOLUTION EARNESTLY REQUESTING MR. ALEJANDRO K. BAUTISTA, HEAD, CENRO, ALBUERA LEYTE TO CONDUCT THE DELINEATION SURVEY OF ALL ILLEGALLY DEVELOPED FISHPONDS AND PRACTICALLY ALL PUBLIC LAND UNDER THE TERRITORIAL JURISDICTION OF BARANGAY LAO THIS CITY";

WHEREAS, the subject barangay resolution has been passed by the Barangay Council of Lao in order to address and totally put-off all illegally developed fishponds along the western part of the swampy areas of Ormoc Bay from Barangay Naungan to the Boundary of Lumintaw, Biasong, Merida Leyte;

WHEREAS, it can be noted that these illegal fishponds have also contributed to the massive flooding along the areas of Brgy. Lao and the neighboring barangays and depriving the legitimate fishpond owners of a better yield;

WHEREAS, in consideration of the general welfare of the residents of Brgy. Lao including its neighboring barangays, this august Body believes that the subject Barangay Resolution is fair and reasonable, hence, the same must be accorded the necessary due course of action;

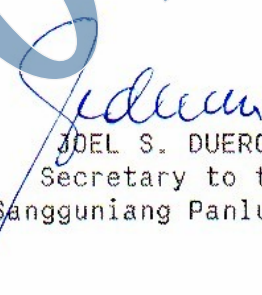
