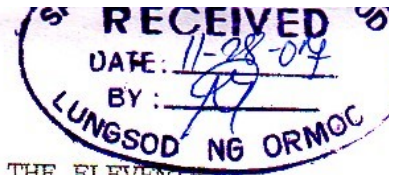

A RESOLUTION APPROVING BAC RESOLUTION NO. 2007-225,
ENTITLED: "A RESOLUTION RECOMMENDING THAT THE
ADDITIONAL WORK FOR THE CONSTRUCTION OF DIVISION OFFICE
(DepEd ORMOC CITY DIVISION OFFICE), ORMOC CITY, BE
UNDERTAKEN THROUGH NEGOTIATED CONTRACT WITH THE SAME
CONTRACTOR, J.E. ARRADAZA CONSTRUCTION AND SUPPLY IN
THE AMOUNT OF FIVE HUNDRED SIXTY THREE THOUSAND SIX
HUNDRED FIFTY-SEVEN PESOS & 76/100 (P563,657.76)" AND
FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN
THE SAID NEGOTIATED CONTRACT.

WHEREAS, this Sanggunian is in receipt of an indorsement dated November 19, 2007 from the Honorable City Mayor Eric C. Codilla, relative to the above mentioned BAC Resolution No. 2007-225 and further requesting that the matter be treated as urgent in order to hasten the completion of the project;

WHEREAS, it has been understood that the original contract of the on-going project is a result of a competitive bidding done last December 27, 2006 which was awarded to J.E. Arradaza Construction and Supply;

WHEREAS, in a Certification of Availability of Funds dated September 26, 2007, the City Treasurer certified that funds are available for the said project to be taken from out of the CY 2007 Special Education Fund (SEF);

WHEREAS, this august Body believes that the said project is an added development to the educational facilities of the city and the procurement of the same through Negotiated Contract is advantageous, just and reasonable hence, it should be accorded due course of action;

WHEREFORE, foregoing premises, considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it


