WHEREAS, the consultant of the above project, SPACES- WOODFIELDS-HYDRONET- GENSON JV, has recommended that it would be advantageous to the City Government of Ormoc if the continuation of above project be negotiated with the existing Contractor as embodied in the Implementation Scheme for the Phase 1B, Construction of Ahag Filtration Gallery" which they have submitted to the CPDO;
