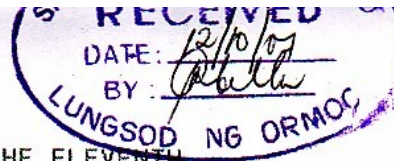

RESOLUTION NO. 2007-120

A RESOLUTION APPROVING BIDS AND AWARDS COMMITTEE (BAC) RESOLUTION NO. 2007-249, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE CONTINUATION OF THE WORK FOR THE RENOVATION/IMPROVEMENT EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE 1B DEVELOPMENT OF WATER SYSTEM-SUB PROJECT SIX/ZONE 1-A, CONSTRUCTION OF A REINFORCED CONCRETE RESERVOIR AND LAYING OF TRANSMISSION AND DISTRIBUTION MAINS (AHAG TO NADONGHOLAN) AT NADONGHOLAN, ORMOC CITY BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE RIGID CONSTRUCTION CORPORATION IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED EIGHTY FIVE THOUSAND THREE HUNDRED EIGHTY FIVE PESOS & 90/100 (P1,885,385.90) ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT.

WHEREAS, the Honorable City Mayor through a letter dated November 26, 2007 has forwarded to this august Body the aforementioned BAC Resolution No. 2007-249 and further requested that the matter be treated as urgent considering that the project is one of the priorities of the city and the same is nearing completion;

WHEREAS, in a letter dated October 30, 2007 the City Planning and Development Coordinator has requested that the herein referred project under BAC Resolution No. 2007-249 be procured and implemented through Negotiated Contract in view of the justification presented by the Consultant of the project, Engr. Pedro Adonis D. Compendio, which pointed out that the basic requirements to warrant project negotiations have been met and that it would be of the best interest of the City Government if the same be awarded thru negotiations to the existing contractor per Government Guidelines;

WHEREAS, the City Treasurer in a Certification dated November 6, 2007, certified that funds are available for the said project to be taken from out of the CY 2007 Supplement Budget No. 8 of the City;



WHEREAS, this Sanggunian believes that the request is just and reasonable hence, the same be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of the City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, duly seconded by City Councilor Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BAC RESOLUTION NO. 2007-249, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE CONTINUATION OF THE WORK FOR THE REHABILITATION/IMPROVEMENT EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE 1B DEVELOPMENT OF WATER SYSTEM-SUB PROJECT SIX/ZONE 1-A, CONSTRUCTION OF A REINFORCED CONCRETE RESERVOIR AND LAYING OF TRANSMISSION AND DISTRIBUTION MAINS (AHAG TO NADONGHOLAN) AT NADONGHOLAN, ORMOC CITY BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, PHILIPPINE RIGID CONSTRUCTION CORPORATION IN THE AMOUNT OF ONE MILLION EIGHT HUNDRED EIGHTY FIVE THOUSAND THREE HUNDRED EIGHTY FIVE PESOS & 90/100 (P1,885,385.90) ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT;




