A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO PURCHASE AND SIGN THE DEED OF SALE FOR ONE (1) RESIDENTIAL BUILDING OWNED BY MR. CREDITUTO CORTES LOCATED AT BARANGAY DONGHOL, THIS CITY, WHICH WAS AFFECTED BY THE REHABILITATION/ENHANCEMENT OF ORMOC FLOOD MITIGATION STRUCTURES AT MALBASAG RIVER IN THE AMOUNT OF NINETEEN THOUSAND NINE HUNDRED FIFTY PESOS (P19,950.00).

WHEREAS, this Sanggunian is in receipt of a letter dated May 28, 2007 from the Honorable City Mayor requesting for the urgent passage of a resolution authorizing His Honor to purchase and sign the Deed of Sale for one (1) Residential Building owned by Mr. Credituto Cortes, located at Brgy. Donghol, this city, in the amount of Nineteen Thousand Nine Hundred Fifty Pesos (P19,950.00);

WHEREAS, said property was affected by the Rehabilitation/Enhancement of Ormoc Flood Mitigation Structures hence, the same shall be purchased by the city in order to satisfy the owner's claim for payment of just compensation;

WHEREAS, the City Appraisal Committee has appraised the said property at NINETEEN THOUSAND NINE HUNDRED FIFTY PESOS (P19,950.00) as contained in their Resolution No. 2007-05, said price is considered as fair, just and reasonable as determined by the committee;
