A RESOLUTION AUTHORIZING THE DESIGNATION OF ATTORNEY RUBEN R. CAPAHI (AS LEAD COUNSEL) AND ATTORNEYS DEMOSTHENES F. TUGONON AND MARIANO Y. CORRO (AS COLLABORATING COUNSELS) VICE ATTORNEY ALAN A. VILLAR WHO WAS PREVIOUSLY NAMED AS CITY LEGAL OFFICER-DESIGNATE IN LBAA CASE NO. 001 ENTITLED "CE LUZON GEOTHERMAL POWER COMPANY, INCORPORATED VERSUS ERLINDA A. SOLANA IN HER CAPACITY AS THE OIC-CITY ASSESSOR OF ORMOC CITY."

WHEREAS, this Sanggunian is in receipt of a letter dated 10 December 2007 from the Honorable City Mayor Eric C. Codilla, addressed the Honorable Vice Mayor and Presiding Officer urgently requesting for the passage of a resolution authorizing the designation of Atty. Ruben R. Capahi (as lead counsel) and Attys. Demosthenes F. Tugonon and Mariano Y. Corro (as collaborating counsels) vice attorney Alan A. Villar who was previously named as City Legal Officer- Designate , per Sangguniang Panlungsod Resolution No. 2007-047 dated August 17, 2007 and to represent the City in the above- mentioned case;

WHEREAS, Atty. Alan A. Villar can no longer represent the City in the said case in view of his assumption to office as Presiding Judge of the Municipal Trial Court of Albura, Leyte as of December 12, 2007;

WHEREAS, because of this development, this august Body deems it proper and reasonable to designate the above-named lawyers as lead counsel and collaborating counsels so that the interest of the City of Ormoc will not be prejudiced;

WHEREFORE, foregoing premise considered, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Public Information jointly seconded by City Councilor Claudio P. Larrazabal and Fernando P. Parrilla; be it
