A RESOLUTION RECOMMENDING TO THE HONORABLE CITY MAYOR
ERIC C. CODILLA THE FOLLOWING THREE (3) NOMINEES FOR
THE POSITION - HEAD OF OFFICE- OFFICE OF THE SENIOR
CITIZENS AFFAIR, THIS CITY, NAMELY:

1. MRS. EDITHA VILLALUZ
2. MR. MANUELITO ESTELA
3. MRS. FE INTO

WHEREAS, the Office of the Senior Citizens Affair (OSCA), this city,
has been established through the enactment of Ordinance No. 137 dated
October 31, 2007;

WHEREAS, in line with the creation of said office is also the creation
of the position- Head of the Office of Senior Citizens Affair as provided
for in Section 4 of Ordinance No. 137 which read as follows:

SECTION 4. A Senior Citizen shall be appointed by the City Mayor
as head of OSCA with the following qualifications:

- a.) A Filipino Citizen and resident of the City of Ormoc
for at least one (1) year;
- b.) A registered voter of the City of Ormoc;
- c.) Able to read and write;
- d.) Must be physically and mentally fit;
- e.) A bonafide member of a duly accredited senior citizen
organization with a track record of at least three
years

WHEREAS, the President of the Federation of Senior Citizens Affair (FSCAO), through a letter dated December 10, 2007 addressed the Honorable Vice Mayor, has endorsed to this august Body the list of nominees for the position- Head of Office- said nominees being chosen in a general assembly by and among the organizations of senior citizens in the city;

WHEREAS, said list of nominees which contains seven (7) candidates/ applicants for the position has been narrowed down to three (3) final nominees by the members of this Sanggunian based on the aforementioned qualifications;

WHEREAS, finding the three (3) final nominees to be qualified for the position - Head of Office- of the Senior Citizens Affair (OSCA), this Sanggunian believes the matter be forwarded to the Office of the City Mayor for final deliberation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Fe S. Lladoc, Chairman, Committee on Social Welfare, jointly seconded by City Councilor Mariano Y. Corro and Sotero M. Pepito; be it
