A RESOLUTION APPROVING BAC RESOLUTION NO. 2007-175
ENTITLED: "A RESOLUTION RECOMMENDING THAT THE SITE
DEVELOPMENT OF AHAG FILTRATION GALLERY AT BARANGAY
DONGHOL, SITIO AHAG ORMOC CITY, BE UNDERTAKEN THROUGH A

WHEREAS, the 10th Sangguniang Panlungsod ng Ormoc is in receipt of
a 3rd Indorsement dated June 18, 2007 from the Honorable City Mayor Eric
C. Codilla pertaining to BAC Resolution No. 2007-175, entitled: "A
RESOLUTION RECOMMENDING THAT THE SITE DEVELOPMENT OF AHAG FILTRATION
GALLERY AT BARANGAY DONGHOL, SITIO AHAG, ORMOC CITY, BE UNDERTAKEN
THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, REX E. MORALES
CONSTRUCTION, IN THE AMOUNT OF FOUR MILLION EIGHT HUNDRED FIFTY ONE
THOUSAND THREE HUNDRED FIFTY NINE PESOS & 37/100 (P4,851,359.37) ONLY"

WHEREAS, the City Planning and Development Coordinator through an
indorsement dated May 30, 2007, has recommended that the aforementioned
site development of Ahag Filtration Gallery be awarded through
negotiations to the existing contractor, Rex E. Morales Construction;

WHEREAS, the consultant of the above project, SPACES-WOODFIELDS-
HYDRONET-GENSON JV, is of the opinion that it would be to the best
interest of the City Government of Ormoc if the above project be awarded
through negotiations to the existing contractor as embodied in the
"Implementation Scheme for Phase 1A; Construction of Ahag Filtration
Gallery" which they have submitted to the City Planning and Development
Office;
