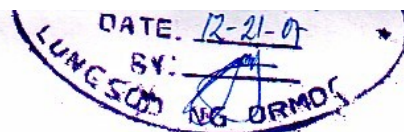
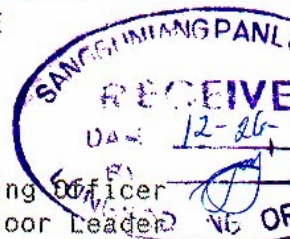

RESOLUTION NO. 2007-132

A RESOLUTION FURTHER AMENDING SECTION 1, RULE V OF THE  
RULES AND PROCEDURES OF THE SANGGUNIANG PANLUNGSOD  
OF ORMOC CITY EFFECTIVE JANUARY 1, 2008.

WHEREAS, Section I, Rule V of the Interim Rules and Procedures of the Sangguniang Panlungsod of Ormoc City has earlier been amended as per Ordinance No. 121, Series of 2005 and Resolution No. 068, Series of 2007;

WHEREAS, the latest amendment under Resolution No. 068, Series of 2007 provides that the time of the Pre-Session Caucus of the Sangguniang Panlungsod be changed from 9:30 in the morning of every Monday to 8:30 in the morning of same day;

WHEREAS, said amendment has already been incorporated in the present Interim Rules and Procedures of the august Body which was adopted in toto by the 11th Sangguniang Panlungsod ng Ormoc;

WHEREAS, upon thorough review of said Rules and Procedures, this Sanggunian believes that the same be amended further to conform with the present needs and activities of the Sangguniang Panlungsod Members and to give the Secretariat additional time to prepare the Agenda Guide, hence, it is expected that the Agenda Guide shall be ready not later than Wednesday afternoon so as to give the SP members an ample time to study the same before the session, by transferring the day of the Pre-Session Caucus from every Monday at 8:30 in the morning as provided for in Resolution No. 068, Series of 2007 to every Friday at same time;

WHEREAS, in consonance to this, Section I of Rule V of the Rules and Procedures of the Sangguniang Panlungsod of Ormoc City will now be read as follows:

RULE V - SESSION, QUORUM AND ATTIRE

Section I, PRE-SESSION CAUCUS - Shall be held every Friday at 8:30 in the morning at the Sangguniang Panlungsod Conference Room for the purpose of determining and discussing the agenda for the regular session provided however, that if a Friday happens to be a holiday the Pre-Session Caucus shall be held any day, the time and place as may be agreed upon by the Kagawads.
