RESOLUTION NO. 2007-137

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A CONTRACT OF LEASE BETWEEN THE CITY GOVERNMENT OF ORMOC AS LESSOR AND THE GOVERNMENT SERVICE INSURANCE SYSTEM (GSIS) REPRESENTED BY ITS MANAGER DR. ESTRELLA E. COLASITO AS LESSEE.

WHEREAS, this Sanggunian is in receipt of 1st Indorsement dated 13 December 2007 from the Honorable City Mayor Eric C. Codilla, requesting for authority to sign the Contract of Lease (renewal) between the City Government of Ormoc as lessor and the Government Service Insurance System (GSIS) represented by its Manager, Dr. Estrella E. Colasito as lessee at the Ground Floor of the Ormoc City Superdome;

WHEREAS, said contract of lease is for a period of three (3) years from January 1, 2008 to December 31, 2011, only which may be renewed on a yearly basis under such terms and conditions as may be agreed upon by both parties;

WHEREAS, this august Body believes that the terms and conditions of said contract are just and reasonable, hence, the same be given the necessary course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws & Ordinances, duly seconded by City Councilor Ruben R. Capahi; be it


