A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF EDUCATION- ORMOC CITY DIVISION FOR THE USE OF THE COMPUTERS AND OTHER FACILITIES OF THE CITY'S E-LEARNING CENTER IN CONNECTION WITH THE LAUNCHING AND IMPLEMENTATION OF THE eSKWELA PROJECT OF THE DEPARTMENT OF EDUCATION

WHEREAS, this august Body is in receipt of an indorsement dated December 19, 2007 from the Honorable City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Agreement (MOA) for and in behalf of the City Government of Ormoc with the Department of Education- Ormoc City Division for the use of the existing E-Learning Center of the city, including its computers and other facilities for the period specified therein in connection with the launching and implementation of the eSkwela Project of the Department of Education in the City of Ormoc;

WHEREAS, the aforementioned project as described in the Memorandum of Agreement will provide the Out-Of School Youths and Adults (OSYs & OSAs) in the City of Ormoc with the opportunity to attain basic education through the use of an Information and Communications Technology (ICT);
