Codilla through 1st Indorsement dated January 8, 2008 has endorsed to this sanggunian the Resolution No. 1, Series of 2008 of the Solid Waste Management Technical Working Group, entitled: "A RESOLUTION REQUESTING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENDORSE TO THE SANGGUNIANG PANLUNGSOD TO GRANT APPROVAL OF THE TEN (10) YEAR- SWM PLAN OF THE CITY OF ORMOC;

WHEREAS, the said Ten (10) year - SWM Plan was completed and finalized with the assistance of the consultants from German Development Services (DED) and Gesellschaft Fur Technische Zusammenarbeit (GTZ-AHT);

WHEREAS, the approval of the SWM plan is a requisite to the issuance of Environmental Compliance Certificate (ECC) by the Environmental Management Bureau (EMB) and is equally important as that of the approval of the Closure Plan of the Old Dumpsite of the city as per SP Resolution No. 2007-131:

WHEREAS, the approval of the SWM plan together with the issuance of the ECC is also necessary prior to the full implementation of the city's SWM Program;
