RESOLUTION NO. 2008-011

A RESOLUTION AMENDING SP RESOLUTION NO. 2007-006 DATED JULY 5, 2007, ENTITLED: "A RESOLUTION DESIGNATING THE CHAIRMANSHIP, VICE-CHAIRMANSHIP AND MEMBERS OF THE STANDING COMMITTEES OF THE 11TH SANGGUNIANG PANLUNGSOD NG ORMOC, AND THE ASSIGNMENT OF COUNCILOR-IN-CHARGE TO EACH OF THE ELEVEN SANGGUNIAN DISTRICTS" BY CHANGING THE CHAIRMANSHIP, VICE CHAIRMANSHIP AND MEMBERSHIP OF SOME OF THE STANDING COMMITTEES AS INDICATED HEREUNDER.

WHEREAS, this august body, in order to properly exercise its functions and to provide the best services to the constituents of Ormoc City, has passed and approved SP Resolution No. 2007-006 providing among others the present Chairmanship and Vice-Chairmanship of the Standing Committees of the Eleventh Sangguniang Panlungsod ng Ormoc;


