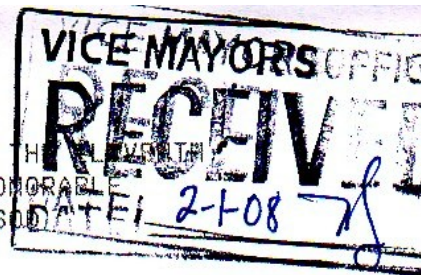

RESOLUTION NO. 2008-016

A RESOLUTION APPROVING BAC RESOLUTION NO. 2008-001, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE CONTINUATION OF THE WORK FOR THE REHABILITATION/IMPROVEMENT/EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE 1B DEVELOPMENT OF WATER SYSTEM-SUB PROJECT SEVEN/ZONE 5, CONSTRUCTION OF A REINFORCED CONCRETE RESERVOIR AND LAYING OF TRANSMISSION AND DISTRIBUTION MAINS AT BRGY. VALENCIA, ORMOC CITY, BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, A.L. GANTUANGCO CONSTRUCTION IN THE AMOUNT OF FOUR MILLION NINE HUNDRED SEVEN THOUSAND FOUR HUNDRED NINETY EIGHT & 99/100 (P4,907,498.99) ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT.

WHEREAS, this Sanggunian is in receipt of an indorsement dated January 11, 2008 from the City Administrator & BAC Chairman, Dr. Dennis Y. Capuyan in connection with the aforementioned BAC Resolution No. 2008-001 and further requesting that the Honorable City Mayor Eric C. Codilla be authorized to enter into and sign said Negotiated Contract;

WHEREAS, in order to ensure early completion of the said project, the City Administrator also requested that the matter be considered as urgent;

WHEREAS, the City Planning & Development Coordinator, Engr. Raoul E. Cam, in his indorsement dated January 7, 2008 has requested that the herein referred project under BAC Resolution No. 2008-001 be awarded to A.L. Gantuangco Construction;

WHEREAS, the Consultants of the Project represented by Engr. Pedro Adonis D. Compendio, through a communication dated January 4, 2008 addressed to the Honorable City Mayor has presented the Implementation Scheme of the project and further concluded that it would be to the best interest of the City Government of Ormoc if the implementation of the same be awarded thru negotiations to the existing contractor per Government Guidelines;

WHEREAS, the City Treasurer in a Certification dated January 7, 2008, certified that funds are available for the said project to be taken from out of the CY 2007 AIP in the amount of P79,306.13 and from the CY 2007 Supplemental Budget No. 8 of the City in the amount of P4,828,192.86 respectively;

WHEREAS, this Sanggunian believes that the request is just and reasonable and, because of its stated urgency, the same necessitates immediate course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance & Appropriation, severally seconded by City Councilors Sotero M. Pepito, Mariano Y. Corro and Jose C. Alfaro, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution APPROVING BAC RESOLUTION NO. 2008-001, ENTITLED: "A RESOLUTION RECOMMENDING THAT THE CONTINUATION OF THE WORK FOR THE REHABILITATION/IMPROVEMENT/EXPANSION OF THE ORMOC CITY WATERWORKS SYSTEM/PHASE 1B DEVELOPMENT OF WATER SYSTEM-SUB PROJECT SEVEN/ZONE 5, CONSTRUCTION OF A REINFORCED CONCRETE RESERVOIR AND LAYING OF TRANSMISSION AND DISTRIBUTION MAINS AT BRGY. VALENCIA, ORMOC CITY, BE UNDERTAKEN THROUGH A NEGOTIATED CONTRACT WITH THE SAME CONTRACTOR, A.L. GANTUANGCO CONSTRUCTION IN THE AMOUNT OF FOUR MILLION NINE HUNDRED SEVEN THOUSAND FOUR HUNDRED NINETY EIGHT & 99/100 (P4,907,498.99) ONLY" AND FURTHER AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN THE SAID NEGOTIATED CONTRACT;
