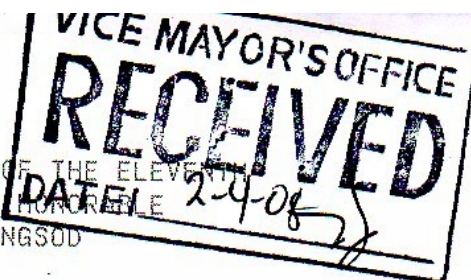

RESOLUTION NO. 2008-017

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE UNPAID ELECTRIC BILL OF PUMPING STATIONS FOR THE PERIOD NOVEMBER 6 - DECEMBER 7, 2007 IN THE AMOUNT OF THREE HUNDRED FORTY SEVEN THOUSAND PESOS (P347,000.00) AGAINST CURRENT APPROPRIATION - ELECTRICITY - PUMPING STATIONS UNDER THE ORWASA OFFICE.

WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc is in receipt of an Indorsement dated January 9, 2008 from the Office of the City Mayor relative to the request of Engr. Gervacio L. Germano, Jr., Waterworks Superintendent II, ORWASA, this city, to charge against current appropriation the unpaid electric bill of pumping stations covering the period November 6 - December 7, 2007 in the amount of THREE HUNDRED FORTY SEVEN THOUSAND PESOS (P347,000.00);

WHEREAS, the City Budget Officer, through 4th indorsement dated January 21, 2008, has recommended to this august Body to grant the City Accountant an authority to charge the aforementioned obligation against current appropriation - Electricity - Pumping Stations under the ORWASA Office;

WHEREAS, in another indorsement dated January 22, 2008 the City Treasurer has certified that funds are available for payment of said obligation to be taken from out of the current appropriation - Electricity Pumping Stations of said office;

WHEREAS, this august Body believes that said request is just and reasonable, hence, the same is to be accorded the necessary course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance, duly seconded by City Councilor Sotero M. Pepito; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE UNPAID ELECTRIC BILL OF PUMPING STATIONS FOR THE PERIOD NOVEMBER 6 - DECEMBER 7, 2007 IN THE AMOUNT OF THREE HUNDRED FORTY SEVEN THOUSAND PESOS (P347,000.00) AGAINST CURRENT APPROPRIATION - ELECTRICITY - PUMPING STATIONS UNDER THE ORWASA OFFICE;
