A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE HEIRS OF BITILIANO MONSANTO AND MAGDALENA FLORENTINO REPRESENTED BY CARMELO F. MONSANTO, SALOME M. CALAMBA AND JOSEPHINE F. MONSANTO.

WHEREAS, this Sanggunian is in receipt of an indorsement dated January 25, 2008 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing His Honor to enter into and sign the Memorandum of Agreement (MOA) in behalf of the City Government of Ormoc with the Heirs of Bitiliano Monsanto and Magdalena Florentino;

WHEREAS, the aforementioned Memorandum of Agreement pertains to the construction of a reservoir, collecting tank and the development of existing natural springs within the property of Bitiliano Monsanto and Magdalena Florentino to be undertaken by the City Government of Ormoc subject to certain conditions as enumerated in the agreement;

WHEREAS, this Sanggunian believes that the project is beneficial to the people and the terms and conditions embodying the same are just and reasonable, hence, the requested authority by the Honorable City Mayor to sign the Agreement be given due course of action;


