RESOLUTION NO. 2008-019

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN THE MEMORANDUM OF COMMITMENT (MOC) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE SMEDSEP-GTZ PROGRAM REPRESENTED BY THE SMEDSEP-GTZ VISAYAS COORDINATOR, VOLKER STEIGERWALD AND DTI REGIONAL DIRECTOR, CYNTHIA R. NIERRAS FOR THE CONTINUED IMPLEMENTATION OF THE LOCAL AND REGIONAL ECONOMIC DEVELOPMENT (LRED) APPROACH IN THE CITY OF ORMOC.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc is in receipt of an urgent indorsement dated January 16, 2008 from the Honorable City Mayor Eric C. Codilla requesting for the passage of a resolution authorizing His Honor to enter into and sign the Memorandum of Commitment (MOC) by and between the City Government of Ormoc and SMEDSEP-GTZ Program for the implementation of the Local and Regional Economic Development (LRED) Approach in the City of Ormoc;

WHEREAS, it can be recalled that the Tenth Sangguniang Panlungsod ng Ormoc has passed and approved SP Res. No. 2005-061 dated April 14, 2005 which paved the way for the implementation of the Phase 1 of the said SMEDSEP-GTZ program in Ormoc City after being identified as one of the pilot LGU to follow the LRED Approach;

WHEREAS, results of the Rapid Economic Appraisal (REA) showed that the City of Ormoc is conducive to LRED Approach thus, continued implementation of the same would foster/ promote economic growth, increase employment rate and income generation;

WHEREFORE, foregoing premises considered, on motion of City Councilor Filomeno P. Maglasang, Chairman, Committee on Trade and Commerce, jointly seconded by City Councilor Claudio P. Larrzabal and Fe S. Lladoc; be it
