RESOLUTION NO. 2008- 020

A RESOLUTION INTERPOSING OBJECTION TO THE PROPOSED
INSTALLATION OF A MACRO CELLULAR/ OUTDOOR SITE BY SMART
COMMUNICATIONS, INC. IN BARANGAY TAMBULILID, ORMOC
CITY.

WHEREAS, this Sanggunian is in receipt of Resolution No. 07-35 of the
Barangay Council of Barangay Tambulilid, this city, entitled: "A RESOLUTION
IMPOSING OBJECTION FOR THE INSTALLATION OF A MACRO CELLULAR/ OUTDOOR SITE IN
BARANGAY TAMBULILID, ORMOC CITY";

WHEREAS, said barangay resolution manifest the stand of the barangay
council of Barangay Tambulilid regarding the application of SMART
Communications, Inc. to install a cell site tower in their barangay;

WHEREAS, during the public hearing conducted in the presence of the
Sangguniang Panlungsod Members, Barangay Chairman of Barangay Linao and
adjacent barangays, Barangay Chairman of Barangay Tambulilid, together with
their Barangay Kagawads, two (2) Representatives from SMART Communications,
and the barangay constituents, the said project of SMART Communications
Inc., was vehemently opposed by the people especially those residing near
the proposed cell site due to possible harmful effects of the project.

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor
Claudio P. Larrazabal, Chairman, Committee on Communications &
Transportation, jointly seconded by City Councilor Sotero M. Pepito and
Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution INTERPOSING
OBJECTION TO THE PROPOSED INSTALLATION OF A MACRO CELLULAR/ OUTDOOR SITE BY
SMART COMMUNICATIONS, INC. IN BARANGAY TAMBULILID, ORMOC CITY.

ADOPTED, February 6, 2008.


