A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO ENTER INTO AND SIGN A MEMORANDUM OF UNDERSTANDING (MOU) FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE NATIONAL STATISTICS OFFICE (NSO) AND THE PHILIPPINE ASSOCIATION OF CIVIL REGISTRARS (PACR).

WHEREAS, this Sanggunian is in receipt of an indorsement dated February 14, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the communication coming from the OIC-Regional Director of National Statistics Office informing of an upcoming simultaneous signing of a Memorandum of Understanding (MOU) in all Local Government Units under Region VIII for the Implementation of the Simplification of Civil Registry Services through the issuance by Local Civil Registrars of Civil Registry "Documents in Security Paper";

WHEREAS, in relation thereto, the Honorable City Mayor requested for authority to enter into and sign the aforementioned Memorandum of Understanding (MOU) in behalf of the City Government of Ormoc with the National Statistics Office (NSO) and the Philippine Association of Civil Registrars (PACR) for the implementation of said Simplification of Civil Registry Services in the City of Ormoc, said request is made urgent considering that the simultaneous signing will be done on February 27, 2008;

WHEREAS, this august Body believes that the Memorandum of Understanding (MOU) is purposely formulated to expedite transactions and to ensure efficient and effective delivery of civil registry services to the general public;

WHEREFORE, foregoing premises considered on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws & Ordinances, severally seconded by City Councilors Rafael C. Omega, Jr., Mariano Y. Corro and Sotero M. Pepito; be it


