Codilla in connection with the communication coming from the OIC-Regional Director of National Statistics Office informing of an upcoming simultaneous signing of a Memorandum of Understanding (MOU) in all Local Government Units under Region VIII for the Implementation of the Simplification of Civil Registry Services through the issuance by Local Civil Registrars of Civil Registry "Documents in Security Paper";
