#### RESOLUTION NO. 2008-038

A RESOLUTION ESTABLISHING THE PERSONNEL SELECTION BOARD, THIS CITY, PURSUANT TO ARTICLE 166, RULE XXII OF THE RULES AND REGULATIONS IMPLEMENTING THE LOCAL GOVERNMENT CODE OF 1791 AND CSC MEMORANDUM CIRCULAR NO. 03, SERIES OF 2001, AND APPROVING AND CONCURRING THE COMPOSITION THEREOF AS MENTIONED HEREIN.

WHEREAS, the implementing Rules and Regulations of the Local Government Code of 1991 particularly Article 166, Par. (a) and (b) of Rule XXII thereof provides that:

## ART. 186. Personnel Selection Board -

- (a) There shall be established in every province, city or municipality a personnel selection board to assist the local chief executive or, where applicable, the presiding officer of the sanggunian, in the judicious and objective selection of personnel for employment as well as for promotion.
- (b) The personnel selection board shall be composed of the local chief executive or his duly authorized representative as chairman, and members to be determined by resolution of the sanggunian concerned in accordance with pertinent civil service law, rules and regulations. A representative of CSC, if any, and the local human resource management officer or his equivalent in the LGU concerned, shall be ex-officio members of the board.

WHEREAS, the Civil Service Commission, in line with the above mandate, has also issued Memorandum Circular No. 03, S. 2001 explicitly stating the necessity of establishing a Personnel Selection Board in every agency which will ensure that equal opportunity will be given to each and every applicant aspiring for any job vacancy;

WHEREAS, in pursuance to the above provisions of the Local Government Code of 1991 and related Civil Service Policy, the Honorable City Mayor in his letter dated January 16, 2008, urgently requested this august Body for the passage of a resolution establishing/creating the Personnel Selection Board of the City Government of Ormoc to be composed of the following members:

WHEREAS, the Personnel Selection Board, once created will be tasked to formulate and initiate innovative schemes in conformity with existing laws which will then serve as a basis in deliberating all applicants to any vacant position in the city government and that of the future promotions of city employees, results of any personnel deliberation conducted by the board shall be subject to the assessment and sound discretion of the appointing authority;

WHEREAS, in view of the vital role of the board in the course of human resource pooling of the city government and considering that said request is in accordance with the law, this sanggunian believes the same necessitates immediate action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Laws and Ordinances, duly seconded by City Councilor Ruben R. Capahi; be it
