A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE UNPAID OBLIGATION OF THE GENERAL SERVICES OFFICE WITH LEYECO V IN THE AMOUNT OF SIX HUNDRED THIRTY TWO THOUSAND TWO HUNDRED SIX PESOS & 74/100 (P632,206.74) AGAINST THE CURRENT APPROPRIATION FOR ELECTRICITY OF SAME OFFICE.

WHEREAS, this august Body is in receipt of an indorsement dated March 5, 2008 from the Honorable City Mayor Eric C. Codilla in connection with the letter-request of Engr. Domardoni C. Cayanong, City General Services Officer, for authority to charge the unpaid obligation of the General Services Office with LEYECO V in the amount of Six Hundred Thirty Two Thousand Two Hundred Six Thousand Pesos & 74/100 (P632,206.74) against the current appropriation of same office;

WHEREAS, in an indorsement dated February 21, 2008, the City Budget Officer recommended that the City Accountant be authorized to charge the said obligation against the current appropriation for Electricity under the Office of the City General Services;

Likewise, the City Treasurer through a certification dated March 10, 2008 has certified that funds are available to settle said obligation to be taken from out of the current appropriation for electricity of the City General Services Office;

WHEREAS, this august Body believes that the request is just and reasonable, hence, the same is to be accorded due course of action;
