

RESOLUTION NO. 2008-047

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA, TO ENTER INTO AND SIGN A MEMORANDUM OF AGREEMENT (MOA) IN BEHALF OF THE CITY GOVERNMENT OF ORMOC WITH THE DEPARTMENT OF LABOR AND EMPLOYMENT, REGIONAL OFFICE NO. 8 REPRESENTED BY ITS REGIONAL DIRECTOR, ATTY. FORTER G. PUGUON, FOR THE PURPOSE OF STRENGTHENING THE PARTNERSHIP CONCERNING THE OPERATION OF THE PUBLIC EMPLOYMENT SERVICE OFFICE (PESO) IN THE CITY OF ORMOC.

WHEREAS, this Sanggunian is in receipt of an indorsement dated November 28, 2007 from the Honorable City Mayor Eric C. Codilla requesting for authority to enter into and sign the Memorandum of Agreement (MOA) in behalf of the City Government of Ormoc with the Department of Labor and Employment, Regional Office No. 8 for the strengthening of its partnership concerning the operation of Public Employment Service Office (PESO) in the City of Ormoc;

WHEREAS, the Public Employment Service Office (PESO), a non-fee charging multi-employment service facility was established in the city through the joint efforts and partnership of the Department of Labor and Employment and LGU of Ormoc as embodied in SP Resolution No. 97-251 dated December 24, 1997 purposely to address unemployment/underemployment problems through the generation, promotion, and facilitation of local and overseas employment for Ormocanons;

WHEREAS, the Department of Labor and Employment, having been mandated to render and extend full technical assistance to the PESO, is in the process of monitoring all PESO Offices and Managers of the respective LGU's as a sort of inventory for them to effectively deliver the required services mandated from their office and to strengthen its partnership with the city in as far as the operation of the PESO is concerned;

WHEREAS, the 11th Sangguniang Panlungsod ng Ormoc, mindful of the benefits that will be derived therefrom, has considered said request as objective and reasonable, hence, must be accorded due course of action;

WHEREFORE, foregoing premises considered, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Agricultural & Industrial Labor & Agrarian Reform, jointly seconded by City Councilor Claudio P. Larrazabal and Mariano Y. Corro; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. 
ADOPTED, March 13, 2008.
