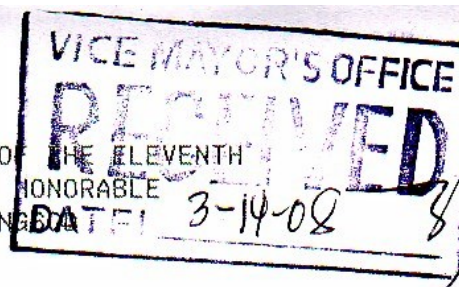

ADOPTED, March 13, 2008.


