RESOLUTION NO. 2008-050

A RESOLUTION REQUESTING THE CITY PLANNING AND DEVELOPMENT OFFICE (CPDO), THE OFFICE OF THE BARANGAY AFFAIRS, THE OFFICE OF THE LIGA NG MGA BARANGAY, AND THE OFFICE OF THE SK FEDERATION, TO STUDY AND MAKE A RECOMMENDATION TO THIS SANGGUNIANG ON THE POSSIBLE MERGER OF BARANGAY DISTRICT VI, THIS CITY, WITH ANY OF THE ADJOINING BARANGAYS.

WHEREAS, at present, Barangay District VI, this city, has no elective barangay officials to run the affairs of the said barangay considering that no candidates filed their Certificate of Candidacy in the last barangay elections;

WHEREAS, being in the said position, the City Government of Ormoc believes that the same be given preferential attention so that public service will not be hampered and that delivery of basic services to its constituents will go on as mandated by law;

WHEREAS, in order to be able to perform these tasks given to the City Government of Ormoc, it is but proper to make a thorough study on the matter to avoid confusion and that the said barangay will be properly represented;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Vice-Chairman, Committee on Laws & Ordinances, duly seconded by City Councilor Rafael C. Omega, Jr.; be it

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution REQUESTING THE CITY PLANNING AND DEVELOPMENT OFFICE (CPDO), THE OFFICE OF THE BARANGAY AFFAIRS, THE OFFICE OF THE LIGA NG MGA BARANGAY, AND THE OFFICE OF THE SK FEDERATION, TO STUDY AND MAKE A RECOMMENDATION TO THIS SANGGUNIANG ON THE POSSIBLE MERGER OF BARANGAY DISTRICT VI, THIS CITY, WITH ANY OF THE ADJOINING BARANGAYS;

RESOLVED, FURTHER, to request the aforementioned Offices to submit their recommendations on or before April 30, 2008;


