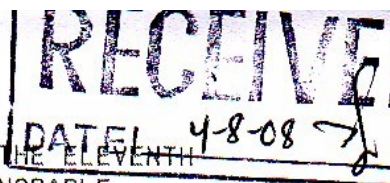

RESOLUTION NO. 2008-Q55

A RESOLUTION AUTHORIZING THE CITY ACCOUNTANT TO CHARGE THE UNPAID ADVERTISEMENT OF THE CITY MAYOR'S OFFICE WITH THE WEST LEYTE EXPRESS FOR THE MONTHS OF NOVEMBER TO DECEMBER, 2006 AND JANUARY TO MARCH, 2007 AMOUNTING TO FORTY FOUR THOUSAND EIGHT HUNDRED PESOS (P44,800.00) AGAINST THE CURRENT APPROPRIATION - ADVERTISING EXPENSES - OF SAME OFFICE.

WHEREAS, this Sanggunian is in receipt of a communication dated March 18, 2008 from the Honorable City Mayor Eric C. Codilla requesting for authority to charge against the current appropriation for Advertising Expenses under the City Mayor's Office the unpaid advertisement with the West Leyte Weekly Express for the months of November to December, 2006 and January to March, 2007 amounting to Forty Four Thousand Eight Hundred Pesos (P44,800.00);

WHEREAS, the City Budget Officer, through an Indorsement dated March 28, 2008 has reiterated that authority be given to the City Accountant to charge the said obligation against the current appropriation - Advertising Expenses - under the Office of the City Mayor;

WHEREAS, in a Certification dated March 31, 2008, the City Treasurer certified that funds amounting to Forty Four Thousand Eight Hundred Pesos (P44,800.00) are available under the current appropriation - Advertising Expenses - of the Office of the City Mayor and can be utilized to settle the aforementioned obligation;

WHEREAS, this August Body believes that the request is just and reasonable, hence, the same is to be accorded due course of action;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Ruben R. Capahi, Chairman, Committee on Finance and Appropriation, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it


