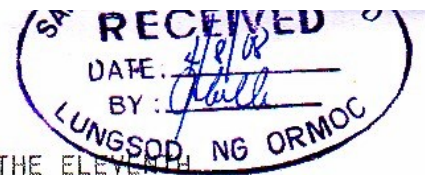

RESOLUTION NO. 2008-056

A RESOLUTION RECOMMENDING TO PNOC-EDC THAT JOINT RESOLUTION NO. 01, SERIES OF 2008 OF THE SANGGUNIANG PAMBARANGAYS OF LAKE DANAO AND TONGONAN, ORMOC CITY, ENTITLED: "A RESOLUTION ENTERING INTO A COMPROMISE AGREEMENT REGARDING THE ROYALTY SHARES FROM PNOC-EDC MAHANAGDONG "A" POWER PLANT" BE GIVEN DUE COURSE.

WHEREAS, the Eleventh Sangguniang Panlungsod ng Ormoc is in receipt of Joint Resolution No. 01, Series of 2008 of the Barangay Councils of Barangay Lake Danao and Barangay Tongonan, this city, entitled: "A RESOLUTION ENTERING INTO A COMPROMISE AGREEMENT REGARDING THE ROYALTY SHARES FROM PNOC-EDC MAHANAGDONG "A" POWER PLANT";

WHEREAS, said barangay resolution embodies the agreement of the respective barangay council of the aforementioned barangays with regards to the sharing of Royalty derived from the Mahanagdong "A" Power Plant;

WHEREAS, both Barangay Governments have agreed that one-fourth percent (1/4%) of the Royalty Shares will be allocated to Barangay Lake Danao while (3/4%) goes to Barangay Tongonan;

WHEREAS, this august body finds said agreement as just and reasonable;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Energy, duly seconded by City Councilor Jose C. Alfaro, Jr.; be it


