RESOLUTION NO. 2008-060

A RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR ERIC C. CODILLA TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF ORMOC AS VENDEE, THE DEED OF ABSOLUTE SALE OF LOT NO. 6-B, PSD-08-014160-D COVERED BY TCT. NO. 36807 AND LOT NO. 8-A-2, PSD 08-015612-D COVERED BY TCT NO. 1-43610 WITH AN AREA OF 1,030 AND 388 SQUARE METERS, RESPECTIVELY SITUATED AT TUOG, BARANGAY DOÑA FELIZA MEJIA, THIS CITY, AS ROAD-RIGHT-OF-WAY CLAIM OF NENITA COQUILLA AND ARTURO COQUILLA AS VENDORS.

WHEREAS, this Sanggunian is in receipt of an indorsement dated March 13, 2008 from the Office of the City Mayor relative to the Road-Right-of-Way Claims of Nenita Coquilla and Arturo Coquilla, for certain lots particularly described as Lot No. 6-B, Psd-08-014160-D covered by TCT No. 36807 and Lot No. 8-A-2, Psd-08-015612-D covered by TCT No. 1-43610 with an area of 1,030 and 388 square meters, respectively situated at Tuog, Barangay Doña Feliza Mejia, this city;

WHEREAS, the City Planning and Development Coordinator, through an indorsement dated January 25, 2008, has confirmed that the subject lots were traversed by the proposed road located at Barangay Doña Feliza Mejia;

WHEREAS, -per Resolution Nos. 2008-01 and 2008-02 dated January 29, 2008 of the City Appraisal Committee, the aforementioned lots which was utilized by the city government as Road-Right-of-Way have an appraised value of THREE HUNDRED PESOS (P300.00) PER SQUARE METER;

WHEREFORE, foregoing premises considered, on motion of City Councilor Demosthenes F. Tugonon, Chairman, Committee on Public Properties, jointly seconded by City Councilors Mariano Y. Corro and Sotero M. Pepito; be it
