

A RESOLUTION APPROVING ORDINANCE NO. 2008-001 OF THE

ENTITLED: "AN ORDINANCE PRESCRIBING THE RATES ON THE
ISSUANCE OF BARANGAY CLEARANCES AND OTHER FEES AND
CHARGES".

WHEREAS, this Sanggunian is in receipt of Barangay Ordinance No.
2008-001 of the Barangay Council of Barangay Magaswe, entitled: "AN
ORDINANCE PRESCRIBING THE RATES ON THE ISSUANCE OF BARANGAY CLEARANCES
AND OTHER FEES AND CHARGES";

WHEREAS, the Sangguniang Panlungsod ng Ormoc, in relation to the


