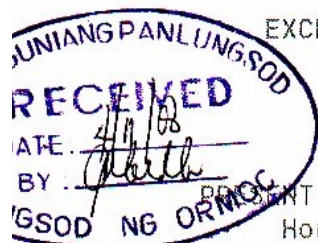
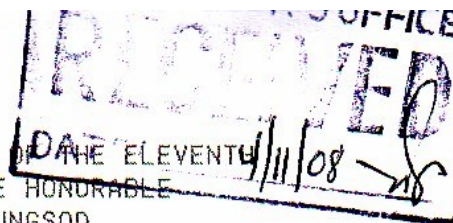

RESOLUTION NO. 2008-062

A RESOLUTION URGENTLY REQUESTING SUPT. ANTONIO P. AGNER, PROVINCIAL FIRE DIRECTOR, PROVINCE OF LEYTE, FOR THE IMMEDIATE RETURN OF ALL ORMOC CITY FIREMEN WHO WERE ALLEGED TO HAVE BEEN ARBITRARILY TRANSFERRED TO THE DIFFERENT MUNICIPALITIES IN LEYTE WITHOUT DUE PROCESS.

WHEREAS, last February 15, 2008, the Eleventh Sangguniang Panlungsod thru Atty. Demosthenes F. Tugonon, Chairman, Committee on Police and Fire, invited FSInsp. Adel P. Bautista of the Ormoc Fire Department to answer some questions relative to his preparation for the Fire Prevention Month;

WHEREAS, during the dialogue this representation inquired Inspector Bautista as to how much his Department regularly received per Quarter, for Repair and Maintenance of Equipment, Fuel (Diesel and Gasoline) and other assistance extended by the Provincial, Regional and National Office;

WHEREAS, Inspector Bautista was also asked to answer who authorized them to deliver water to private entity/person, and how much they are charging, whether it is receipted and who received it;

WHEREAS, last February 2008 to the surprise of the Members of the 11th Sangguniang Panlungsod, a xerox copy of an order coming from Provincial Fire Director Antonio P. Agner, transferring Ormoc Firemen to the different Municipalities of Leyte without replacement, putting the lives and properties of the Ormocanon in danger;

WHEREAS, the Members of the 11th Sangguniang Panlungsod consider the act of transferring Ormoc Firemen without due process as harassment and intimidation to cover up alleged irregularities committed;

WHEREAS, the 11th Sangguniang Panlungsod Members started to doubt that there is an alleged collusion between inspector Bautista and unseen Provincial Officials, which resulted to the transfer of Ormoc Firemen without due process;

WHEREFORE, FOREGOING PREMISES CONSIDERED, on motion of City Councilor Sotero M. Pepito, Chairman, Committee on Public Information, jointly seconded by City Councilor Claudio P. Larrazabal and Mariano Y. Corro; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution URGENTLY REQUESTING SUPT. ANTONIO P. AGNER, PROVINCIAL FIRE DIRECTOR, PROVINCE OF LEYTE, FOR THE IMMEDIATE RETURN OF ALL ORMOC CITY FIREMEN WHO WERE ALLEGED TO HAVE BEEN ARBITRARILY TRANSFERRED TO THE DIFFERENT MUNICIPALITIES IN LEYTE WITHOUT DUE PROCESS;

ADOPTED, April 10, 2008.

Codilla, the City Administrator, the Regional Director, DILG, Tacloban City, the Provincial Fire Director, Supt. Antonio P.
