A RESOLUTION RESPECTFULLY REQUESTING HON. ANGELO REYES. SECRETARY OF THE DEPARTMENT OF ENERGY, TO FURNISH LGU ORMOC CITY, THE SPECIFIC AMOUNT/S AVAILABLE TO IT, AS A HOST CITY, PRODUCING GEOTHERMAL RESERVOIR, AS PROVIDED FOR IN ER 1-94, AS AMENDED, FOR ITS INFORMATION AND GUIDANCE IN THE PROPER PLANNING, PROGRAMMING AND IMPLEMENTATION OF THE DIFFERENT PROJECTS THAT CAN BE FUNDED THEREFOR.

WHEREAS, ER 1-94, as amended, provides several financial benefits to NOST LGUs, that is, where energy resources and/or energy generating facilities are located, as determined in Section 5, thereof;

WHEREAS, LGU Ormoc City is a host city as it is the site of producing geothermal reservoir, and therefore, entitled to the benefits provided for in the aforementioned ER 1-94, as amended;

WHEREAS, ER 1-94, as amended, provides the following financial benefits to non-highly urbanized city, like Ormoc City, to wit: a) Electrification fund at 50% of one centavo per kwh; b) Development and Livelihood fund at 25% of one centavo per kwh; c) Reforestation, Watershed Management, Health and/or Environment Enhancement Fund at 25% of one centavo per kwh;

WHEREAS, in order to maximize the aforementioned financial benefits to the host LGU, needs proper planning and programming which can only be done if the funds available therefor are known in advance;

FOREGOING PREMISES CONSIDERED, on motion of City Councilor Mariano Y. Corro, Chairman, Committee on Energy, jointly seconded by City Councilors Jose C. Alfaro, Jr. and Ruben R. Capahi; be it
