## RESOLUTION NO. 2008-067

A RESOLUTION RESPECTFULLY REQUESTING THE SECRETARY OF THE DEPARTMENT OF ENERGY (DOE), HON. ANGELO REYES, AND THE SECRETARY OF RUDGET AND MANAGEMENT (DBM), HON. ROLANDO ANDAYA TO RELEASE ON A QUARTERLY BASIS THE SHARE OF LGU OPMOC CITY IN THE MATIONAL WEALTH.

WHEREAS, LOU Ormoc City is a Host City being the site of a producing geothermal reservoir;

WHEREAS, the Local Government Code of 1991 (RA No. 7160) Sec. 289 thereof gives LGU's an equitable share in the proceeds derived from the utilization and development of the national wealth within their respective areas;

WHEREAS, Ormoc City has been receiving royalty fees from PNOC-EDC on a quarterly basis;

WHEREAS, PNOC-EDC has been recently privatized, and the procedure in the allocation and release of the LGU's share in the national wealth from private companies is outlined in Circular No. 92-09-03, in the following manner, to wit:

- DOE collects the total government share from the private company on a quarterly basis;
- 2) DOE allocates the LGU, share on the government share collected for the year;
- 3) DOE submits to the Department of Budget and Management (DBM) the allocated LGU share on or before March 15 of the following year;
- 4) DBM releases the respective shares of the LGU's.

WHEREAS, the foregoing procedure clearly shows that the share of the LGU in the national wealth will now be released on a yearly basis, instead of on a quarterly basis as was the procedure before;

WHEREAS, the change in the frequency of releases of LGU's share in the national wealth, from quarterly to yearly, is patently disadvantageous to the concerned LGU, and moreover, is contrary to the provision of Art 398, par. (b) of the RRILGC which states:

"(b) The allotment representing the share of each LGU shall be released without need of any further action, directly to the provincial, city, municipal or barangay treasurers, as the case maybe on a quarterly basis within five (5) days after the end of each quarter, and which shall not be subject to any lien or holdback that may be imposed by the National Government" (Underscoring supplied for emphasis)

FOREGOING PREMISES CONSIDERED, on MASS MOTION of the Body; be

RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution RESPECTFULLY REQUESTING THE SECRETARY OF THE DEPARTMENT OF ENERGY (DOE), HON. ANGELO REYES, AND THE SECRETARY OF BUDGET AND MANAGEMENT (DBM), HON. ROLANDO ANDAYA TO RELEASE ON A QUARTERLY BASIS THE SHARE OF LGU ORMOC CITY IN THE NATIONAL WEALTH;
