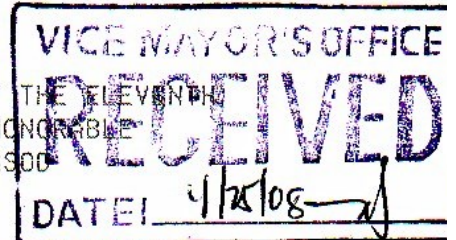

Councilor Mariano Y. Corro and Sotero M. Pepito: be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a A RESOLUTION

ADOPTED, April 24, 2008 .


RESOLVED, FURTHER, to furnish copies of this resolution each to His
