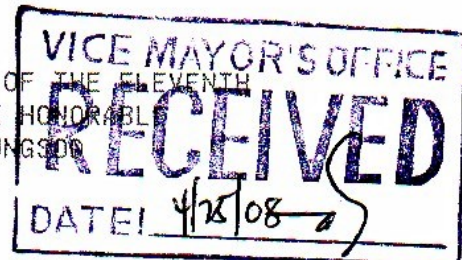

Councilor Jose C. Alfaro, Jr. and Ruben R. Capahi; be it


RESOLVED, AS IT IS HEREBY RESOLVED, to pass a resolution A

ADOPTED, April 24, 2008.


RESOLVED, FURTHER, to furnish copies of this resolution each to His
